

BORD BAINISTÍOCHTA GHAELSCOIL MHUSCRAÍ
TUAIRISC AONTAITHE – AGREED REPORT

Ag cruinniú den Bhord Bainistíochta ar an dáta thuasluaite, cuireadh na nithe seo faoi bhráid an Bhoird:

Miontuairiscí ón gcruinniú deireanach, Comhfhreagras, Tuairisc an Chisteora, Tuairisc an Phríomhoide agus Tuairisc Mhaoirseachta ar Chosaint Leanaí.

- Costas don 8ú seomra ranga seolta chuig na Roinne ó Innealtóirí MHL. Ag feitheamh ar fhreagra ón Roinn.
- Beidh ceist parlaiminte sa Dáil curtha ar an Aire Oideachais maidir le suíomh don scoil. Buíochas le Colm Burke TD a bheidh ag cur na ceiste.
- Tá an bóthar deisithe lasmuigh den scoil. Buíochas ag dul go BFS Garveys as ucht na hoibreacha seo.
- Scaipeadh salann i rith an drochaimsir le déanaí. Tugadh fé ndeara nach raibh aon shalann scaipithe ar an mbóthair lasmuigh den scoil agus beidh ar úinéirí an bhóthair déileáil le seo amach anseo.
- B'fhéidir go gcuirfidh an scoil isteach ar oibreacha eigeandála le haghaidh coras teasa nua má leanann an córas an slí ina bhfuil sé anois.
- Tá painéal gréine curtha isteach anois againn sa scoil mar chuid de scéim na Roinne.
- Deineadh faomhadh ar an Stráitéis Tinrimh.
- Bhí na cuntaisí scoile 2024/2025 deimhnithe agus seolta chuig an FSSU agus an Foras Patrúnachta i mí na Nollag.
- Freagraí faighte ó thuistí maidir lena smaointí don Chód Iompair nua.
- Deineadh plé ar an éide scoile.
- Eagrófar imeacht tiomsaithe airgid do bhuachaill i Naíonáin Mhóra atá breoite níos déanaí sa téarma.
- Deineadh plé ar úsáid iomhánna na bpáistí ar mheán shóisialta na scoile.
- Imeachtaí an téarma curtha in iúl don Bhord.
- Buíochas ag dul go custaiméirí an Muskerry Arms as ucht a gcuid síntiús Nollag chuig na scoile.

At a Board of Management meeting held on the date shown above, the following were presented to the Board: Minutes from the last meeting, Correspondence, Treasurer's Report, Principal's Report and Child Protection Oversight Report.

- A quotation for the proposed eight mainstream classrooms has been submitted to the Department by MHL Engineers and is currently awaiting approval.
- It was noted that a Parliamentary Question regarding the provision of a permanent site for the school is due to be raised in Dáil Éireann next week. The Board of Management expressed its appreciation to Deputy Colm Burke TD for raising this matter.
- Road works have recently been completed on the roadway by Garveys BFS. The Board of Management acknowledged and welcomed these long-overdue repairs.

- During the recent period of cold weather, salt was distributed within the school yard. It was noted, however, that the roadway and pathways outside the school grounds were not salted or gritted. This matter will need to be addressed by the relevant road owners going forward.
- It was noted that the school may be required to apply for an Emergency Works Grant to facilitate the installation of a new heating system should the current system continue to prove unreliable.
- Solar panels have been installed over Unit 3 as part of a Department of Education and Skills scheme.
- The school's Attendance Strategy was formally ratified by the Board of Management.
- The 2024/2025 school accounts have been certified and a copy was sent to the FSSU and school Patron in December.
- Input was sought and received from parents by way of an online survey for consideration in the updating of the Code of Behaviour.
- The matter of the school uniform was discussed.
- It was agreed that a school fundraiser will be organised later in the term, in consultation with the Parents' Association, to support a pupil in Naíonáin Mhóra who is currently unwell.
- The issue of the use of pupils' images on the school's social media platforms was discussed.
- The Board of Management was informed of the school events scheduled for the current term
- The Board expressed their thanks to the customers of the Muskerry Arms for their Christmas donation to the school.
